

The US shock troops (intell cartel, government cartel) are mounting an operation aimed at smearing opponents of an oppressive tax system with charges of money laundering. Take notice.

You will be hearing about this soon. It will come out in various ways. It will be a lie.

This is hot off the press.

It pushes other items I was going to discuss off the page.

The operation goes like this: Accuse innocent people of possible drug connections or schemes to shift \$\$\$ around illegally. The cartels are up to their ears in illegal drug ops and illegal shifting of \$\$\$ from bank to bank and country to country every day.

The cartels use Interpol and IRS and other agencies and the police of foreign countries to harass people who are using legal means to protect their assets. The cartels want to own everything.

Two weeks ago I was approached by a man who is a captive of "let's share and give and cooperate and all be victims and let the government help everybody and be humanitarian and believe all the medical toxic hype" thinking...

This man was not a representative of real humanitarianism. He was and is a dupe, a complete dupe. He is working with and for the US government, or

what he thinks is the US government. He is a stupid agent on a very low level of the cartels.

He was trying to rope me in and make me see that "tax avoidance" is a very dangerous thing. He is not aware that people on the pol left and the right have, for a very long time, objected to taxes which fund various insane programs of "governments," which is to say, cartels.

He is a viper in sheep's clothing, who believes that trying to protect everyone against "dangerous thinking" is a mission from God. His God is a "sharing caring social worker" who wants to make the world into a sea of weak debilitated unfree people who must rely on outside help to accomplish anything.

He is the prime "new citizen" of the New World Order who will rat on anyone he thinks is doing something odd or threatening to the Program.

The Program is: Undermine everyone's belief in his own ability and desire to become free and powerful and self-sufficient and independent.

That is the program.

This man hoped he could enlist me in aiding his agenda. He hoped that I would want to give him information about people I knew who were anti-government.....the government for him is God.

I know slime and he is slime.

This man recruited himself to become an active agent in "the battle" to make everyone conform to a world without freedom. He thinks that endless victimhood is the same thing as freedom.

I toyed with him for a bit to see where he was going. He finally admitted he was trying to get information on people who claim that the 16th Amendment (which established the income tax) was never actually ratified.

He thought this "antitax" campaign was a conspiracy against government, and if it succeeded it would disable the help that citizens need from their government.

I said, "Whether that Amendment was actually ratified or it was brought into being through fraud is a matter of evidence and fact." He said nothing. There was nothing he could say.

He brought up the fact that in the last 90 days, over 500 children in California have been officially diagnosed with autism. He said, "This is going to cost the state of California over a billion dollars--just for these 500 kids (see my story on this in the last day or so on [nomorefakenews](#))."

I said, "Are you a doctor?"

He said, "Let's just say I work with medical agencies."

"Which ones?"

"I'd rather not say."

We discussed the fact that each one of these kids will cost the state of California \$2 million for lifetime care. I said, "You see, each one of these kids is very precious, a commodity for the medical forces that will collect the \$2 million for care that will never cure them."

He didn't like that.

He wanted to play the sympathy card. Then I told him that the MMR vaccine causes autism. So to give the vaccine raises the chances of more profits for the medical cartel.

He didn't like that.

A friend from one of the major networks has confirmed to me that there is now being built a campaign to discredit those who believe the government is in any way collecting taxes on a fraudulent basis. This campaign is conscious and is enlisting a number of media dupes who sit in anchor chairs and edit copy and decide what is shown and not shown...

Several days ago, a man who lives and operates a business out of Central America had his office raided by police. They were looking for evidence of money laundering. They found none. This man was helping clients invest their \$\$ offshore. That's what he does for a living. He doesn't launder, he doesn't deal drugs. He just makes an honest living.

They attacked the wrong man for their purposes. I'll tell you why. Let me say first, I am not a religionist. I don't adhere to any religion. That's just the way it is. I am not a believer, as they say, although I do have a number of spiritual ideas of my own. But I have worked with a number of Christians over the years. People whose beliefs cannot be shaken by any force on Earth. I respect them. These people I have worked with are not racists and they are not any of the things other people accuse them of. They are admirable. And this man who was raided in Central America is one of

those men. They chose the wrong guy, because this man will go to the wall for what he thinks is right. He will not lie down or go away. He will not give in. If they persist, he will shake the tree.

His clients are not fat cats, they are not big-time docs who push poison on their patients and make millions from it. His clients are just people.

In other words, this op in Central America, which originated out of the US of course, was aimed at freedom.

But there is a kicker in all this. If the US government and media (government cartel and media cartel) push this campaign---making the phrase "offshore" equal "crime"--they will get themselves in a snarl. They will be attacking the same investments and the same repositories the fat cats use.

In the long run, that could well become a very big mistake. Because there are a large number of people out there who will begin to ring the bell and reveal the WHOLE truth about who is parking \$\$\$ offshore....and who is parking drug money offshore...and who is racking up profits from laundering \$\$\$....THOSE are the real crimes....and in trying to scare honest people who are legally putting assets offshore, the NY bankers and the druglords and the CIA and a lot of other very shady types will get their assets revealed....

Now....the stats above on autism in California reveal a med cartel op...not just for immense profits BUT TO MAKE MORE AND MORE PEOPLE DEPENDANT ON THE GOVERNMENT....the gov't. cartel and the med cartel work hand in glove on

this: create a system in which med care costs huge \$\$ and then under the guise of humanitarianism give more people insurance that derives from the gov't....do you see? "We will give you all the (toxic) drugs you demand for your catastrophic illness....but under government auspices.....and you will then be part of the government, a slave....."

Hooked. Trapped. And addicted.

Also, autism is one of those catch-all conditions with symptoms but no cause...therefore, it can be diagnosed when in fact a number of DIFFERENT toxicities can be the cause....severe food allergies, sensitivities to chemicals and dyes in food, vaccines, aspartame, med drugs, and so on...while the med researchers "valiantly" look for a cause, kids fold up and become out of touch....

When I mentioned this to the tired dupe I was talking to, his eyes went a little frantic. He began to wonder whether he was in over his head. He was.

OK. Within the 7 cartels, more rifts are developing. The med cartel is very upset that the military and intell cartels have been instrumental in allowing Depleted Uranium (DU) to be used in the Balkans and Iraq (see my stories on nomorefakenews today). For the med cartel, this blunder is more proof that the other cartels are crazy and stupid and inferior....because the DU scandal is driving European countries further into their shells and away from collective identity as "Europe," away from being "part of the new governing force of the planet."

The med cartel is saying essentially, "Just hold your horses and don't do anything stupid and let us put everybody on Prozac and everything will work out the way we want it to..."

The med cartel is trying to tell governments all over the world, "Don't you understand the plan? Put more and more med care under government, and soon we will have everybody in the box. Everybody will be beholden to us. We will flood them with toxic drugs and call it caring care and people will buy it and we will have them under control and in a weak state..."

Again, the 7 cartels that run the world: GOVERNMENT, MONEY, MILITARY, INTELLIGENCE, ENERGY, MEDIA, MEDICAL. If you think about it, which one has the best PR? Which one on balance has garnered the most public faith? The MEDICAL cartel. And it knows it. So it's asking the other cartels to minimize their blunders and let the toxic war on the body take over.....

Note: The recent assassination of Congo President Kabila was a cartel operation. Several cartel cutouts have been involved in the war to take over the incredibly rich mineral areas of that African country: gold, cobalt, manganese, diamonds, uranium, copper, zinc, germanium, lead, silver, tungsten, iron.

The cutouts include several "mercenary companies" that supply soldiers: MPRI (US), Executive Outcome (South Africa), and Sandline (England). A higher level cutout, the US Pentagon, helped with military training and planning.

President Kabila was installed as a result of that war, and his job was to

cede these mineral areas to large corporations (more cartel cutouts). But he rebelled against external control of his country. So he was murdered.

The Congo is listed on the cartel world map of regions as a colony--supplies raw materials to other regions for use in manufacture of finished goods. Kabila broke the prime rule--he tried to win independent status for his nation...make it prosperous and a real player in trade and commerce....and that was his last mistake.

Important to know: In 1996, the Congo government's monopoly on gold in the country was transferred, in great part, to a private company. Barrick Gold Corporation. Of Canada. On the board of Barrick? Brian Mulroney, former prime minister of Canada; Paul Desmaris, president of the Canadian Power Corporation; Karl Otto Paul, former director of Central Bank of Germany; and GEORGE BUSH, SR.

An international assemblage of power brokers that moves us quite a bit higher on the chain of cartel command. This gold snatch was not, in other words, the work of a single country---THERE ARE NO SINGLE COUNTRIES ANYMORE--it was the work of agents acting on behalf of a global consortium which believes in the planetary rule of a few over the many.

Meanwhile, remember that the Congo is one of the named centers for AIDS in Africa. AIDS is a code word for depopulation. "Eliminate great numbers of people and keep the minerals." The Congo was a target of the WHO smallpox
